

# Instructions for USA Immigration Medical Examination Services

#### **Salient Features**

- The process comprises of one visit, except in rare cases where two or more visits are required.
- All visits/diagnostics will be done at Clifton Medical Services (CMS). However, in case of further investigations or unavailability of services, cases may be referred to AKUH Stadium Road Campus.
- Please note that in absence of required documents, the visit will be postponed.
- For positive TB cases, DOT therapy will be administered at CMS with additional charges of Rs.
   440 per visit.
- Package prices are exclusive of vaccinations and further referrals.

#### **COVID-19 Vaccine Requirement**

- All applicants applying for US immigration check-up should bring up their Covid 19 vaccine certificate (issued by NADRA) with details of 2 doses at the time of medical check-up registration.
- Vaccines administered should include those approved from WHO/USA FDA for emergency use.

### **Exemption from COVID-19 Vaccination**

- As per NCOC guidelines, children under 12 years are currently exempted from immunization.
- Applicants with any underlying medical condition that is a contraindication for vaccine are also exempted. Such applicants should bring supportive documents for the said condition(s).

# Step 1: Documentation verification and diagnostic tests Appointment Based Visit: 9 am - 12 pm | Monday-Friday | Wait time, approximately 4 hours

Please bring following documents with you:

- Original Passport with validity of at least 7 months, along with 1 copy
- Letter from the US Embassy along with 1 copy
- · Complete present residential address and intended address in USA
- Corresponding email address and active contact number
- Date of birth of all children (for mothers only)
- Complete vaccination records
- After documentation verification:
- Applicants 15 year and above will need:
  - A chest x-ray. In case the applicant is pregnant, the chest x-ray will still be required but will be done with proper protective shielding and consent. Pregnant women who do not wish to get it at that time may wait till after the delivery. However, their medical examination will be delayed until their chest x-ray is done and they will need to inform the Embassy.
  - o **Blood Test for Syphilis**, if between the ages of 18 and 44. Fasting is not required.
  - Urine Test for Gonorrhea, if between the ages of 18 and 44. Fasting is not required.
- Applicants under 15 years will need a blood test for IGRA. Fasting is not required.
- Applicants under 2 years only need a consultation.
- Please ignore auto sent SMSs for diagnostic tests.

# Step 2: Physician consultation, vaccination and additional tests, if advised by the physician Appointment visit subject to clinic schedule | Monday-Friday | Approximate time 2 hours

Physician will review the above documents and

- Laboratory tests from the last six months.
- Eyesight. Please do not wear lenses.
- · List of medicines that you use daily.

Please keep some additional funds available for vaccinations/diagnostics and further referrals, if advised by the physician.

## Step 3: Collection of Xray | Approximate time ½ hour

Applicant must present his/her original passport collect the x-ray envelope.
